The interview displays in real-time on a computer screen in another room so that the interview can be viewed by others not physically in the interview room. iRecord then burns the interview onto a DVD that can be viewed by all parties involved, and can easily be viewed in court as evidence in the pending case. iRecord is user-friendly, allowing the police officers, prosecutors, and anyone else involved to easily record and manage interviews.
